The draft proposed SIP revision evaluates progress made in implementing the meas-ures included in Pennsylvania's Re-gional Haze SIP revision, which was submitted to the U.S. Environ-mental Protection Agency (EPA) on December 20, 2016, and which re-ceived a limited appropriat to EPA ceived a limited approval by EPA (see 77 FR 41279, July 13, 2012 and 77 FR 48061, August 13, 2012) and a limited disapproval by EPA (see 77 FR 33642, June 7, 2012). This proposed SIP revision is sub-mitted in accordance with the visibil-

mitted in accordance with line visibility and regional haze provisions of sections 169A and 169B of the toderal Clean Air Act (CAA), 42 U.S.C. §§ 7491-7492, and the federal Regional Haze Fluid codified at 40 CFR § 51.308.

This proposed SIP revision is intended to address the requirements for periodic reports evaluating progress towards the Reasonable Progress towards the Reasonable Progress Goals established for mandalary Class I areas where visibility may be impacted by Pennsylvania sources (40 CFR § 51.308(g)). In accordance with 40 CFR § 51.308(h)(1), the proposed SIP revision includes a negative declaraon southful the program of the 2010 revision includes a negative declaration that turther revision of the 2010 Regional Haze SIP is not needed at this time to achieve established goals for visibility improvement and emissions reductions.

The Regional Haze Rule, in 40 CFR § 51.308(i), requires states to consult with the Federal Land Managers (FLMs) at least 60 days prior to the scheduled public hearing on the proposed Regional Haze SIP revision. Section 169A(d) of the CAA requires states to include a summary of the conclusions and recommendations of the FLMs in the notice to the public. The FLMs were provided an opportunity for consultation with the U.S. National Park Service and the U.S. Department of Agriculture's Forest Service providing comments to the Department; the United States Department of the Interior's Fish and Wildfild Service did not comment. A copy of all comments submitted by the FLMs to the Department, and the Department's responses, is available in Appendix N of the proposed SIP revisitor.
